DESCRIPTION: PRIDE'S CHLORINATED DISH SCRUB is a concentrated, high alkaline, low suds liquid warewash detergent containing chlorine for fast removal of stubborn stains. Its unique blend of water conditioners allows CHLORINATED DISH SCRUB to produce sparkling results, even in the hardest water conditions. The shipping container provides a convenient reservoir for any automatic dispensing equipment. Care should be exercised when using this product in the presence of silver, pewter and aluminum. CHLORINATED DISH SCRUB contains strong alkali materials that could damage soft metals; DO NOT mix with ammonia solutions.

DIRECTIONS:

- Store pail in a safe place, preferably under the dish machine.
- Clear dispensing tube of obstructions.
- Machine water should be changed when noticeably dirty.
- Set detergent feeder for correct solution concentration. For medium hard water (4.5 – 8 grains/liter) use 2 – 5 ounces per 10 gallons of water. For hard (8+ grains/liter) use 3 – 6 ounces per 10 gallons or water. Use a warewash alkali titration test on the wash water. Titration should be between 6 to 10; 6 for soft water and 10 for hard.
- Wash temperature should be maintained between 120° - 150° F for optimum results.
- For proper sanitizing. Rinse water temperature should be 150° F.
